Subject: Grant of Ex-gratia in lieu of bonus to the employees of Transport Department including employees of the HREC, Gurgaon for the year 2007-08.

Reference your office note No.6974-F.C. dated 07.10.2008 on the subject cited above.

Sanction of Governor of Haryana is hereby accorded to the payment of ex-gratia in lieu of bonus @ 3500/- for the year 2007-2008 to the employees of the Transport Department including employees of the HREC, Gurgaon.

2. For the Financial Year 2007-08, an ex-gratia in lieu of bonus shall be given to all the class III & IV employees including employees working on daily wages and contractual basis of the Haryana Roadways including Class III and IV employees of the Haryana Roadways Engg. Corporation, Gurgaon, the employees working in the Government Central Workshops and Ministers Car Section (excluding drivers) in proportion to the period they worked on commercial side of the department; the employees who worked on the commercial side of the headquarter of Transport Department; and the employees of non-commercial side of the headquarter of the Department only in proportion to the period they worked on commercial side @ Rs.3500/- for the year 2007-08.

3. The above mentioned ex-gratia in lieu of bonus shall be paid subject to the following conditions:-

- i) Those employees who had been removed/dismissed from service shall not be entitled to ex-gratia payment. However, they will be paid ex-gratia in proportion to the period they worked in the year 2007-08.
- ii) Employees who have been removed from service before completion of 240 days service shall not be entitled to ex-gratia in lieu of bonus.
- iii) Employees under suspension will be paid ex-gratia in lieu of bonus for the period they remained under suspension provided they are reinstated without any punishment after their reinstatement.

4. The expenditure involved shall be met out from the existing budget of the current financial year 2007-08 under the head '3055-Road Transport (Non-Plan)'

5. This sanction issues with the concurrence of Finance Department conveyed vide their UO No. 1/59/83-11/GII dated 24.10.2008.
