1. E-tender are invited from General Insurance Companies for insurance of 4100 (Approx) ordinary buses of Haryana Roadways (directly or through representative) as per terms & conditions with latest amendments laid down under Motor Vehicles Act and further as per detail given below:-
  - a) Approximately 800 new buses which are likely to be added to the fleet during the period May, 2018 to April, 2019 and buses which have been added during the period of May, 2016 to April, 2018 will be put for insurance on comprehensive basis. Remaining buses are to be got insured on 3<sup>rd</sup> party basis.
  - b) The initial cost of the ordinary bus is approximately Rs. 27.00 lacs.
  - c) The 3<sup>rd</sup> party rate of insurance for non-commercial vehicles of department, such as truck, tankers, crane and driver's training school vehicles are also to be given separately in the same tender on separate sheet.
  - d) Separate rates for 3<sup>rd</sup> party and comprehensive insurance shall be given including basic rates, premium per seat and rate of premium for CNG/HSD operational buses for cities like Delhi, Gurugram, Chandigarh and other Districts in Haryana alongwith rate of discount offered in OD premium.
2. E-Tender shall be sent in a super-scribed with the words "**E-Tender for the insurance of buses of Haryana Roadways**" on the envelop and shall reach in the office of Director General State Transport, Haryana, 30-Bays Building, 2<sup>nd</sup> Floor, Sector-17, Chandigarh latest by 6.04.2018 upto 14:00 hrs and the same will be opened on the same day at 15:00 hrs in the presence of the Tender representatives who may wish to attend. No e-tender received after 14:00 hrs of 6.04.2018 by post/person shall be accepted under any circumstances.
3. The rates shall also be quoted through Broker or representative and such rates shall be accompanied by the approval granted by the Headquarter of the concerned insurance companies otherwise the same shall not be considered.
4. Telegraphically/conditional/incomplete e-tender will not be considered.
5. The Director General State Transport, Haryana will have the right to reject all or any other e-tender without assigning any reason.
6. The rates from private companies shall not be entertained.
