Subject:- Regarding treating the Drivers and Conductors on contractual basis on or after 1-01-2003 as regular and release of consequential benefits.

In continuation of Government letter No. 1/82/2012-IT (II), dated 25-06-2014 on the subject noted above.

2. The matter regarding treating the contractual Drivers and Conductors of Transport Department, Haryana recruited on or after 01-01-2003 under Haryana Transport Department (Group-C) Haryana Roadways Service Rules, 2003 as regular one was engaging the attention of the Government after issuance of letter dated 25-06-2014 vide which such type of drivers and conductors were granted regular pay scales notionally upto 31-12-2013 and actual w.e.f. 01-01-2014.

3. Even after issuance of letter dated 25-06-2014, the benefits of ACP, Monthly Financial Assistance, Family Pension (joined the service upto 31-12-2005) and NPS (who joined the service on or after 01-01-2006) could not be extended due to non-mentioning the word "regular from initial date(s) of joining" to these drivers and conductors as regular from their initial date(s) of appointment/joining rather granted regular pay scales from initial date(s) of joining.

4. Now after detailed deliberations with the representatives of the various Employees Unions, the Government has decided to treat the drivers and conductors recruited contractually on or after 01-01-2003 as regular from their initial date(s) of joining with the following benefits:-

- (i) The benefits of ACP, Pay fixation and Monthly Financial Assistance will be given notionally upto 31-07-2016 and on actual basis w.e.f. 01-08-2016.
- (ii) The drivers and conductors who joined the services upto 31-12-2005 will be governed under the Family Pension Rules, 1964 and the drivers and conductors joined the services on or after 01-01-2006 will be governed by the New Pension Schemes, 2006.

5. This issue has been approved by Chief Minister, Haryana with the concurrence of Finance Department, Haryana conveyed vide U.O. No. 3/6/2013-1FG-11/36686 dated 24-11-2016.
